The Washington College Bound Scholarship program is a commitment of college scholarship funds to selected Washington middle school students. To be eligible, you must meet the family income standards, make a pledge to graduate from a Washington high school with a 2.0 GPA or higher, and be a good citizen. Family income from your senior year will be verified upon high school graduation.
